I will send this video to you and to my lawyers. You are simply not doing your job and taking the domestic violence against my daughters seriously. I hope your conscience is ok with that. And I also hope your conscience is ok that your clients' mother sits homeless while they want more time with me. JoJo has been crying herself to sleep at night for the last 5 nights I haven't been there.

I am dismayed and disgusted by your lack of concern for my girls. There is documented abuse in this case and you simply ignore it.
