



Husband of NYC prosecutor who said she'd been driven to assisted suicide by cancer and his domestic abuse QUILTS law firm after probe by his bosses

- Allan Kassenoff quit his job after his ex-wife Catherine Kassenoff accused publicly claimed he abused her and that it led to her assisted suicide
- Kassenoff was a patent litigator at Greenberg Taurig before he resigned
- Catherine shared a Facebook post prior to her death claiming Allen had physically abused her throughout their marriage

The man who was accused of abusing his NYC prosecutor wife who allegedly died by assisted suicide has quit his job as a litigator following a leave of absence.

Officials with Greenberg Taurig said in a statement that Allan Kassenoff had tendered his resignation following a probe into him by his bosses at the firm.

Allen was a patent litigator and shareholder at the agency before he stepped down, although it's unclear whether he was pushed out or did so willingly.

The man had been on leave after ex-wife Catherine Kassenoff shared in a [Facebook](#) post that he had allegedly abused her, which - along with a terminal [cancer](#) diagnosis - factored into her decision to die.

'The firm has concluded its review of the situation to determine Allan Kassenoff's status with the firm,' a statement posted by Greenberg Taurig read.

'Our primary obligation is to maintain and protect the core values and best interests of our firm, our clients, our lawyers and our professional staff,' it continued.

In a shocking and heartbreaking post on Facebook, Catherine had asserted that Allan abused her and was attempting to ruin her life prior to her death.

The woman, who at one point worked as special counsel to New York Gov. Kathy Hochul, said she had a victim to a 'predatory' court system that kept her kids away.

The couple had, according to Catherine's post, been engaged in a nasty custody battle for their three daughters that continued to escalate.

In the post Sunday evening, Greenberg Taurig shared that following the departure of Allan, they would be looking out financially for the couple's kids.

'The firm is sensitive to the needs of the three children,' the firm wrote in their post, labeling the children as 'the primary victims of the situation.'

'Therefore will be creating a dedicated trust fund with an independent trustee for the sole benefit of these children, to be voluntarily funded by the lawyers and staff of our firm,' the post continued.

In a separate post in early June, Greenberg Taurig said they planned to look into the claims made by Catherine on social media.

The firm explicitly stated that no evidence of abuse had been uncovered by judges or attorneys throughout their custody trial but that they took the claims seriously.

'Nevertheless, the firm will be conducting its own investigation to determine his status with the firm,' the statement posted online read.

'In the meantime, he is taking a voluntary leave of absence to focus on his family,' adding that he had been awarded sole legal custody of the girls.

DailyMail.com reached out to Allan's attorney, Gus Dimopoulos Monday evening but he did not respond in time for this report.
