



# Liability Release and Waiver

The Share Institute, Inc., d/b/a ShareLove.Fund (hereinafter “ShareLove.Fund”) is a yoga school that specializes in empowering women through a junior yoga teacher certification program (the “Activities”). By signing below, I, the Participant (or the Participant’s legal guardian), agree that:

## Safety

For my safety and that of others, I will comply with ShareLove.Fund or its agents’ instructions and directions.

## Understandings

I understand that participation in the Activities has risks that may arise from my own actions or the actions of ShareLove.Fund, other participants, or others present at the site. These risks, which include risks of bodily injury and pregnancy complications, may be inherent to the Activities or may arise from conditions and activities at the sites and unforeseen acts of third parties. I understand that ShareLove.Fund does not control, and is not liable for, the conduct of participants or others present at the sites, and that ShareLove.Fund is not staffed to monitor participants in the Activities at any time.

## Awareness and Assumption of Risk

I confirm my understandings as stated above. With that information and awareness, I am knowingly participating in the Activities, and I knowingly assume and accept the risks of all injury, illness, disease, death, property damage or loss, financial obligation, loss of privacy, and all other consequences that may result, directly or indirectly, from my participation in the Activities or my presence at or travel to the site(s), regardless of the cause.

## Waiver and Release of Claims

I waive and release ShareLove.Fund and its directors, officers, agents, employees, volunteers and affiliates, and any sponsors of the Activities (collectively, the “Released Parties”) from any and all liability, claims, costs, and damages of any kind which I or my heirs, next of kin or legal representatives may have or which may later accrue, resulting or arising directly or indirectly from (a) my participation in the Activities or presence at or travel to the Activities’ sites or (b) any first aid, transportation or medical care provided to me in connection with my participation. This release and waiver includes, in each such case, all claims in respect of the risks noted above, known and unknown, regardless of the cause or whether such claims arise from tort, contract or otherwise, and even if caused by negligence, whether passive or active. I agree not to sue any of the Released Parties on the basis of these waived and released claims.

I affirm that I am of legal age and am freely signing this document. **I have read this form and fully understand that by signing this form, I am giving up legal rights and/or remedies that may be available to me.**

I affirm that I am the parent or legal guardian of the participant and am freely signing this document on behalf of my minor child. **I have read this form and fully understand that by signing this form, I am giving up legal rights and/or remedies that may be available to me and my child.**

## Medical Care Consent

I authorize ShareLove.Fund to provide me first aid and to arrange medical assistance, transportation, and emergency medical services for me if I get hurt during my participation in the Activities. I will be responsible for any costs related to my medical treatment and transport. I understand that ShareLove.Fund does not provide health, medical, disability, or other insurance coverage for me.

## Use of My Name and Image

During my participation in the Activities, ShareLove.Fund may take photos or videos of me and any works I create through my participation in the Activities. I consent to the use by ShareLove.Fund of my image, voice, name, works, and/or story in any format, including video, print, or electronic (collectively, “Materials”), as ShareLove.Fund may deem appropriate for other program, archival, promotional or other purposes. ShareLove.Fund may make the Materials available on its website, in its publications, or through any other media, including social networking platforms. I waive any right to inspect or approve the Materials or to receive any payment. I grant to ShareLove.Fund all copyrights in the Materials and waive any legal claims relating to the Materials, including those relating to copyright or rights of publicity or privacy.

## Information Collection

I consent to ShareLove.Fund collecting personal information from me and using it for planning, organizing, promoting, and conducting the Activities, and for following up with me after my participation.

## Who this Affects; Severability

I understand that this agreement will be binding for the duration of my involvement in ShareLove.Fund. This Liability Release and Waiver will be legally binding not only on me but also my heirs, next of kin, and legal representatives, and will run in favor of, and may be enforced by, each of the Released Parties. This Liability Release and Waiver will be binding to the fullest extent permitted by law. I agree that this Agreement shall be governed by and interpreted in accordance with the laws of the State of New York. If any provision of this Liability Release and Waiver is found to be illegal, invalid or unenforceable, the remaining terms will be effective.
